Deposit & Venue Hire

A deposit of \$750 which constitutes venue hire is required within 7 days of making your booking. We cannot guarantee your booking is secure until the deposit is received.

Start and Finish Times

The client agrees to begin the function at the agreed time and to have all guests vacate the function space at the agreed time. All functions must conclude by 12 midnight.

Prices

Every effort is made to maintain prices but these are subject to change at the discretion of the function centre manager allowing for seasonal market cost fluctuations.

Firm prices will be finalised four months prior to the date of the function.

Liquor & Food

Liquor and food cannot be brought onto the function centre premises for consumption before, during or after the function.

Damage or Loss

The client is financially liable for any damage sustained, or loss incurred, to function centre property, fixtures and fittings, whether through their own actions or those of their guests, contractors or sub-contractors.

Access to Other Areas of Property

There is strictly no access to other parts of the Rosevears Vineyard property including vineyard, winery and cellar door unless this has been fully agreed with Rosevears Vineyard management prior to the event.

Cancellations

In the event of cancellations a cancellation fee will be charged with the following conditions.

- Cancellation 2 to 3 months prior to the date of the function, deposit will be retained.
- Cancellation 21 days to 2 months prior to the function, deposit will be retained plus a fee of 10% of the estimated cost of the function.
- Cancellation 7 to 21 days prior to the function, deposit will be retained plus a fee of 25% of the estimated cost of the function
- Cancellation less than 7 days prior to the date of the function, deposit will be retained plus a fee of 50% of the estimated cost of the function.

Payment of Account

Payments may be made by cash, bank cheque or credit card. Full payment for the event must be made at least 3 working days prior to the event. Where a consumption bar is to operate during the event a credit card pre-authorisation will be required and the account must be finalised before leaving the function centre on the night. Numbers notified at time of final payment are the agreed numbers for the night. No refunds will be made due to lower numbers attending the actual function.

Please note that function centre management reserves the right to change menus, beverage lists and prices, re-decorate, re-furbish, paint and make alterations at our discretion.
